DIRECTIONS FOR USE

R-WAY increases the effectiveness of pesticides and is designed for use with certain pesticides. Always follow the label of the specific pesticide for detailed adjuvant use directions. **R-WAY** may be used for agricultural, commercial and industrial uses with pesticides labeled accordingly. Specific usage and restrictions contained on the pesticide label have precedence over use rates contained on this label.

The following use rates are considered to be adequate for most applications. Some pesticides may require different rates for optimum effect.

Ground Applications:

Use 1 quart per acre, or 2 to 4 quarts per 100 gallons of spray solution. Some labels may suggest using 1-1.5% v/v. See specific pesticide label for instructions on the use rate of **R-WAY**.

Aerial Application, Low Volume, CDA:

Use 2 to 8 ounces of **R-WAY** per acre. See specific pesticide label for instructions on the use rate of **R-WAY**.

Mixing:

Fill spray tank half-full with water. Then add pesticide per label recommendations and continue filling. Add proper amount of **R-WAY** last, and continue agitation.

USE PRECAUTIONS

R-WAY increases the effectiveness of pesticides. During periods of high temperatures and/or extreme humidity, some pesticides may become more active. It is recommended that a small test area be treated if such conditions prevail. Test areas are also recommended in the treatment of new crop varieties or highly inbred crop lines.

STORAGE & DISPOSAL

Store product in original container. Do not store near heat or open flame. Do not reuse container. Do not contaminate water, food or feed by storage or disposal. Store in a cool, dry place away from oxidizing agents. Keep packaging closed, securely fastened and upright.
