DIRECTIONS FOR USE

SHAKE WELL BEFORE USING

TRADITION 93 nonionic surfactant is a general purpose, low foaming spray adjuvant that improves the effectiveness of herbicides, insecticides, fungicides and defoliant. **TRADITION 93** increases spray contact activity and improves spray penetration by providing more uniform spray coverage and by decreasing the spray surface tension. **TRADITION 93** helps solubilize the leaf cuticle for better absorption.

HERBICIDES

TRADITION 93 may be used with many post emergence herbicides. Use rates vary from 1 to 4 pints per 100 gallons (unless otherwise directed) of spray solution with most post emergence herbicides that recommend the use of a nonionic surfactant. The herbicide product label should be consulted for actual use rates.

INSECTICIDES, FUNGICIDES, ACARICIDES

TRADITION 93 may be used at a rate of 2 to 8 ounces per 100 gallons of spray solution to enhance the wetting characteristics of an insecticide, fungicide or acaricide application. The product label should be consulted for actual use rates.

DEFOLIANTS

TRADITION 93 may be applied at a rate of 2 pints per 100 gallons of dilute spray solution when application is at the rate of 10 or less gallons per acre. Use 4 pints of **TRADITION 93** per 100 gallons of spray solution when the application rate is greater than 10 gallons of spray solution per acre. The defoliant product label should be consulted for actual use rates.

STORAGE & DISPOSAL

Store product in original container. Do not store near heat or open flame. Do not reuse container. Do not contaminate water, food or feed by storage or disposal. Store in a cool, dry place away from oxidizing agents. Keep packaging closed, securely fastened and upright.
